JUROR OF SELECTION AND AWARDS

Lyn Asselta

is a widely recognized pastel artist, a Signature Member of the Pastel Society of America (PSA), a Master Circle recipient of the International Association of Pastel Societies (IAPS), and a member of the Salmagundi Club. She is the founder of the First Coast Pastel Society (FL), a Member of Excellence of the Southeastern Pastel Society, and is also a member of the American Artists Professional League, and the Eastern League of Professional Artists. In 2009, Lyn had the honor of being an Artist in Residence for the National Park Service in Acadia National Park in Maine. Her work was recently featured in the February 2016 issue of Pastel Journal and her painting "Blue Morning, Crescent Beach" appeared on the cover.

ELIGIBILITY REQUIREMENTS

- This Exhibition is open to all artists over the age of 18 working in the soft pastel medium.
- 80% of the exposed surface must be dry pastel. No oil pastels.
- There is no size limitation.
- Must be entirely the work of the artist and not copied from other artists' work, photos or publications.
- Must not have been created under supervision (as in a workshop or class).
- Must have been completed within the last 5 years.
- May not be glazed works with a finished surface of matte acrylic, resin, or solvent varnish.
- If the work is not for sale, check "NFS" on the entry form.

ENTRY FEES

MEMBER PRICING: \$30 for up to three images for members of the Pastel Society of North Carolina.
[please make certain that your memberships dues are up to date]
\$10 each for additional entries for a total of six entries allowed per artist.

NON MEMBER PRICING: \$40 for up to three images for non-members.
\$10 each for additional entry for a total of six entries allowed per artist.

ENTRY PROCESS

- Online entry using Online Juried Shows
- Go to www.onlinejuriedshows.com and sign in or register a user account.
- Up to 6 images may be submitted --up to 2 paintings may be accepted to show per artist.
- No file-naming restrictions. Juror will not see the file name.
- JPEGs must not show mat, frame, etc., and must be an accurate representation of the artwork.

- Entry form must be filled out in its entirety. List sizes up to the nearest inch. Submitted images must not include matting or frame. Crop the photos to include only the artwork. Be sure your images are right-side-up.
- Before uploading your images, make sure they are smaller than 4MB, but at least 1920 pixels on the longest side at 72 dpi. Images should be in JPEG format, RGB color space. The ENTRY FEE is paid via PayPal/Credit card to On Line Juried Shows upon submission. No checks accepted. All entry fees are nonrefundable and must be paid by the entry deadline.

- The artist's email will be listed with each accepted entry and the artist will be entirely responsible for any sales.
- No commissions will be charged.
